KRUGERRAND

The company deals exclusively in “Bullion Krugerrands” i.e. those Krugerrands that are for purposes of investment in gold bullion. In South Africa the coins carry legal tender status and are therefore underwritten by the central bank. The Krugerrand carries a price premium due to its high standard of crafting. Owing to its high international brand recognition it enjoys exceptional international acceptability.

Fineness: The Krugerrand consists of 22 karat gold (916.7 fineness or 91.67% purity). The coin contains one full Troy Ounce of gold i.e. 31.1034768g.

Dimensions: In addition to one ounce of gold the Krugerrand contains a small amount of copper to add durability. The total weight of the coin is 33.93g. See www.realkrugerrand.com.
